

Legal notice

Extent

You are currently on the official Rentalp website for C.I.T.I (Coopérative Informatique du Tourisme et de l'Immobilier - Online Tourism and Real Estate Cooperative). The principles set out below shall also apply by analogy to other information sent to customers, such as for example newsletters. The remarks regarding usage of the portal apply to all Group websites. This notice shall be without prejudice to the special provisions applicable to other websites belonging to undertakings from the C.I.T.I Group with legal personality. The principles applicable to the usage of this portal may be amended at any time with full legal effect.

Intellectual property rights and other rights

C.I.T.I is the owner and exploiter of this portal. The trade marks, names, titles, logos, photographs, designs, texts and other elements included on it are all owned by Group undertakings with legal personality or by their contracting parties. The onscreen viewing, down-loading or copying of pages from the website shall not give rise to any entitlement (usage right, intellectual property right, etc...). All reproduction (in full or in part), transmission (electronically or otherwise), amendment, networking or other usage of the portal for the purpose of publication or for commercial purposes shall be prohibited unless agreed to in advance in writing.

Limitation of liability

C.I.T.I. rejects all liability (including liability for negligence) which may result from the access or lack of access to all or part of the website, or from its usage. Access to the portal and its usage are not guaranteed. The portal contains links to third party websites which are not operated or monitored by C.I.T.I. Consequently, C.I.T.I. rejects all liability in respect of their content. This rejection of liability shall also apply to compliance with the legal provisions applicable to data protection by the operators of these websites.

Transfer of data over the internet

As a network which is open to and accessible to any party, the internet is not able to provide a secure environment. Even if packets of individual data are transmitted in principle in encrypted form, this procedure does not apply either to the third party operator or the recipient. Moreover, even if the third party operator and the recipient are both located in Switzerland, it is possible that data may transit through foreign countries providing a lower level of data protection than Switzerland. Accordingly, C.I.T.I. rejects all liability in relation to the security of data during transit over the internet.

Collection and usage of information

When a visitor accesses the internet portal, various data are registered (for example the visitor's IP address, the date of access, the name of the file downloaded, etc.). Such personal data shall not be used in any manner. Data will only be examined in anonymised form for statistical purposes, for example in order to establish the daily number of visits to the website. The data shall be processed confidentially. They shall not be transmitted outside the Group or to any third party unless required pursuant to applicable legislation or by the competent prosecuting authorities.

Cookies

All access to the portal shall entail the registration of a small file ("cookie") within the memory of the visitor's computer. This file will be used exclusively in relation to an anonymous survey of the number of visitors.

Data security

The security of personal data registered is guaranteed.
